EXECUTIVE ORDER NO. 2015-01

RELATIVE TO RESCINDING EXECUTIVE ORDER NO. 2011-08 AND PLACING THE AGENCY FOR HUMAN RESOURCES DEVELOPMENT UNDER THE ADMINISTRATIVE SUPERVISION OF THE DEPARTMENT OF LABOR

WHEREAS, it is the duty of the Governor under Section 1422c(c) of the Organic Act of Guam to examine from time to time the structure of the Executive Branch and to determine and effect such changes as are necessary to promote effective management; and

WHEREAS, pursuant to 22 G.C.A. Section 1103, the purpose of the Department of Labor ("DOL") is "to foster, promote and develop the welfare of the wage earners of Guam, to improve their working and living conditions, and to advance their opportunities for occupational training and profitable employment"; and

WHEREAS, pursuant to 19 G.C.A. Section 22102, the purpose of the Agency for Human Resources Development ("AHRD") is to "be responsible for the coordination of manpower needs, assessment and employment programs funded under the provisions of local and Federal statutes," as well as to administer workforce development programs and to seek, apply and otherwise obtain federal, private and other funds for use in manpower and other programs; and

NOW, THEREFORE, I, EDDIE BAZA CALVO, *I Maga'Lahen Guåhan,* Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby order as follows:

1. **Executive Order 2011-08 is rescinded**. The Agency for Human Resources Development (AHRD) is restored to its status as it existed under Executive Order No. 2003-16, and prior to the issuance of Executive Order No. 2011-08.



- 2. **DOL** has Administrative Supervision over AHRD. The Director of the Department of Labor and the Director of the Agency for Human Resources Development shall take all necessary steps to transfer and place administrative and supervisory control of AHRD to DOL. Upon completion, the management of AHRD and the supervision of its personnel shall be under the authority of DOL and the DOL Director.
- 3. All personnel, duties, and responsibilities of AHRD, following promulgation of this Executive Order, shall fall under the supervision of DOL.
- 4. This Executive Order is not intended to directly or indirectly remove, harm or diminish any protections, afforded by law, to the employees of AHRD. Nor does this Executive Order create any right or benefit, substantive or procedural, enforceable at law or equity by a party against Guam, its departments, agencies or instrumentalities, its officers or employees or any other person.
- 5. This Executive Order is not intended to transfer or consolidate the functions of AHRD with DOL, but rather to place administrative supervision of AHRD with DOL and the DOL Director.
- 6. Any Executive Order heretofore promulgated in conflict herewith is repealed insofar as any conflict is concerned.
