EXECUTIVE ORDER NO. 79-26

FLORAL DESIGNATIONS OF THE RECREATIONAL PAVILIONS AT THE YPAO BEACH PARK

WHEREAS, Flora of Guam is amongst her most significant natural Resources; and

WHEREAS, the Ypao Beach Park is the central leisure recreational Park of the Territory of Guam; and

WHEREAS, Floral beauty is closely identified and synonymous to the clean air and tropical surroundings of Guam's beaches; and

WHEREAS, the Pavilions of Ypao Beach Park serves as a source of enjoyment for the people of Guam and visitors alike; and

WHEREAS, the Floral designations of these Pavilions is proper and compatible with the aesthetic settings;

NOW, THEREFORE, I, PAUL M. CALVO, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby order the following floral designations of the Pavilions at the Ypao Beach Park:

- 1. The Amphitheatre shall be designated as PUTI TAI-NOBIO AMPHITHEATRE.
- 2. Shelter Al shall be designated as PLUMERIA PAVILION.
- 3. Shelter A2 shall be designated as ASUCENA PAVILION.
- 4. Shelter A3 shall be designated as CHICHIRICA PAVILION
- 5. Shelter Bl shall be designated as BUTON PAVILION.
- 6. Shelter B2 shall be designated as DAMA DE NOCHE PAVILION.
- 7. Sheiter B3 shall be designated as ADAHLIA PAVILION.
- 8. Shelter Cl shall be designated as ADELFA PAVILION.
- 9. Shelter C2 shall be designated as MARIGOLD PAVILION.
- 10. Shelter C3 shall be designated as ROSAT PAVILION.
- il. Shelter D1 shall be designated as ILANG-ILANG PAVILION.

- 12. Shelter D2 shall be designated as LIRIO PAVILION.
- 13. Shelter D3 shall be designated as POINSETTIA PAVILION.
- 14. Shelter El shall be designated as GOLONDRINA PAVILION,
- 15. Shelter E2 shall be designated as GLADIOLA PAVILION.
- 16. Shelter £3 shall be designated as MIRASOL PAVILION.
- 1/. Shelter Fl shall be designated as CADENA PAVILION.
- 18. Shelter F2 shall be designated as FLORES ROSA PAVILION.
- 19. Shelter F3 shall be designated as LILA PAVILION.
- 20. The main Pavilion shall be designated as SAMPAGUITA PAVILION.

This order shall be effective upon approval of the Governor.
