EXECUTIVE ORDER NO. 63. 24

ESTABLISHMENT OF "BRODIE MEMORIAL SCHOOL FOR  
EXCEPTIONAL CHILDREN" WITHIN THE GOVERNMENT  
OF GUAM.

WHEREAS, the Marianas Association for Retarded Children, hereinafter referred to as the "Association", is a private nonprofit organization formed to promote the general welfare and training of mentally retarded persons; and

WHEREAS, the Association has since 1960 furnished training facilities for mentally retarded persons through the Brodie Memorial School for Exceptional Children; and

WHEREAS, the Legislature of Guam has generously appropriated money over the years for the financial support of the Brodie Memorial School for Exceptional Children through grants issued by the Governor; and

WHEREAS, the Seventh Guam Legislature, through Resolution No. 109, and the Association, through its own Resolution, have urged that the Brodie Memorial School for Exceptional Children be incorporated in and made a part of the Government of Guam; and

WHEREAS, it is a proper and necessary government function to furnish suitable training and education to eligible children as contemplated by the program;

NOW, THEREFORE, pursuant to the authority vested in me by the Organic Act of Guam, it is hereby ordered as follows:

1. The Brodie Memorial School for Exceptional Children is hereby established and made a part of the Department of Education, Government of Guam, to be known by that name.

2. The working staff of the Brodie Memorial School for Exceptional Children is hereby transferred to the classified service of the Government of Guam, and the Department of Labor and Personnel is directed to take suitable action to implement this section.

3. Government land in the vicinity of Tumon Junior-Senior High School or any other suitable location shall be set aside for the use of the school, and the Department of Land Management is directed to proceed with site location.

4. The Marianas Association for Retarded Children is hereby authorized to act as an Advisory Board to the Board of Education, Department of Education, insofar as the Brodie Memorial School for Exceptional Children is concerned.


5. Any unencumbered monies appropriated for the training of retarded children is transferred to the Department of Education, and the Department of Finance is directed to effect this transfer.

6. The Department of Education is directed and authorized to accept any and all property of the Brodie Memorial School for Exceptional Children donated by the Marianas Association for Retarded Children for the uses contemplated herein.

7. This order shall be effective November 1, 1963.
