

Public Law No. 32-055, which was introduced as Bill No. 127-32, will help the resource-strapped Department of Revenue and Taxation capture more tax revenue. The law will appropriate \$100,000 to DRT to help implement the "Cash Economy Enforcement Act of 2011." That program aims to properly assess taxes to cash-based transactions and businesses.

"DRT and its employees do the best they can with the limited resources it has. I thank Speaker Won Pat, Senator Muña Barnes and the other senators who put their money where their mouths are. These lawmakers understand the tough position these employees are in, so they are willing to give the support to DRT to capture more tax revenue," Governor Calvo said.

An act to add a new § 79601.2 to Article 6 of Chapter 79, Title 21, Guam Code Annotated, relative to the establishment of a War on Terror Fallen Heroes Monument to honor Guam's men and women who have courageously and selflessly served our island people and our nation in the War on Terror, and who have made the ultimate sacrifice.

An act to amend the Title of Chapter 37, and to add a new Article 2 to Chapter 37 of Title 9, Guam Code Annotated, relative to Home Invasion.
