Public Law 116-136 (the CARES ACT) established the Coronavirus Relief Fund (CRF) and appropriated \$150 billion to the Fund. Guam received \$117,968,258 of these funds. The Government of Guam was required to report expenditures to June 30, 2020 to US Treasury and in a report dated July 23, 2020 and revised on August 24, 2020, an interim report for the District of Columbia and territories - Costs incurred by Spend Categories, US Treasury reported costs incurred of \$29,124,815 by Guam.

Attached is a report of costs incurred and encumbrances recorded within this Fund to August 31, 2020. This report compares expenditure against the budget transmitted to you on May 5, 2020 as amended by Bureau of Budget and Management Research.
