I spoke with State Surgeon General Cruz on this matter and we should be able to meet today. On our side, we would like Dr. Cruz, Francis Santos, myself, and maybe Sophia to be able to meet.

I do want to clarify and make sure our conversation starts on the same set of facts.

- 1. On March 24, 2020 the Governor executed EO 2020-06, establishing the CURE Action Team. This appointed Dr. Cruz as the Chief Medical Advisor and allowing him to direct facilities, providers, and supplies. This would be based on standardized operating procedures (SOPs)
- 2. To this date, no SOPs have been developed and no facilities, providers, nor supplies have been directed for government use.
- 3. The government is actively working to help clinics get reimbursed for medicaid/mip more quickly to help with cashflow.
- 4. There is no legal or equitable way to subsidize a clinic for past operations outside of the CURE framework. An idea about developing a grant program may help if it's competitive.. but that will take time and cannot be retroactive.

We appreciate AMC and all of its efforts to keep the island safe. We wish others would have taken this position and exercised Dr. Nguyen's healthy and responsible messaging as it relates to COVID-19

## Dear Jacque:

Thank you for arranging the conversation with your client, AMC, yesterday afternoon. We apologize that COL Michael Cruz, the Guam National Guard State Surgeon General and the Governor's Chief Medical Advisor, was not available and that we were not in a position or have the authority to make any decisions.

First off, we would highly encourage that your client change its position regarding seeking expedited reimbursement for Medicaid/MIP reimbursement. Other clinics have provided us with over FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) worth of billings. If your client has been seeing Medicaid patients, this amount does not seem insignificant. Please let us know if your client changes its position on this issue.

Second, we want to reemphasize that we have not been informed by any of the members of the Physicians Advisory group on any developments pursuant to Executive Order 2020-06. That order allowed the Chief Medical Advisor to develop a strategy and standard operating procedures for working with certain clinics. Its main purpose was to allow for government liability coverage to extend to any operations undertaken in support of the Public Health authority's COVID-19 response efforts.

It is our understanding that AMC continues to want to be considered to assist the Public Health authority as a Tier 2 clinic. We fully support that involvement; however, we need more direction from the Physicians Advisory group, which includes your client through its designated representative. We have not received any indication that any medical facilities, supplies, or providers have been formally directed to act as government entities. This would have been in the form of a contract for procurement purposes. And as you know, procurement law does not allow for payment of services prior to the execution of an agreement.

## Attorney Yanza:

Thank you for your letter. To this date, we have not been informed by any of the members of the Physicians Advisory group on any developments pursuant to Executive Order 2020-06. That order allowed the Chief Medical Advisor to develop a strategy and standard operating procedures for working with certain clinics. Its main purpose was to allow for government liability coverage to extend to any operations undertaken in support of the Public Health authority's COVID-19 response efforts.

It is our understanding that FHP continues to want to be considered to assist the Public Health authority as a Tier 2 clinic. We fully support that involvement; however, we need more direction from the Physicians Advisory group, which includes your client or a designated representative. We have not received any indication that any medical facilities, supplies, or providers have been formally directed to act as government entities. This would have been in the form of a contract for procurement purposes. And as you know, procurement law does not allow for payment of services prior to the execution of an agreement.

Your previous proposal called for the government to provide your client with THREE HUNDRED FIFTY THOUSAND DOLLARS (\$350,000.00) for a two-week period. The proposed MOU did not clearly identify what the scope of work would be and that it would be limited to services directly related to COVID-19. Your recent letter provides a description of your client's operating expenses for a twenty-five (25) day time period. That description correlates with the proposal in your MOU. Please know that the government is not and cannot be in a position to subsidize a private entity's normal operations.

## RE: MEMORANDUM OF UNDERSTANDING

Dear Sophia and Haig:

Thank you for your April 23, 2020 letter.

Under the Emergency Health Powers Act, 10 G.C.A. et seq., in particular, § 19502(b), the Department of Public Health and Social Services, has the statutory authority:

To require a health care facility to provide services or the use of its facility if such services or use are reasonable and necessary to respond to the public health emergency as a condition of licensure, authorization or the ability to continue doing business on Guam as a health care facility. The use of the health care facility may include transferring the management and supervision of the health care facility to the public health authority for a limited or unlimited period of time, but shall not exceed the termination of the declaration of a state of public health emergency.

Under Executive Order 2020-06 by Maga'hågan Guåhan, Lourdes A. Leon Guerrero issued on March 23, 2020, ordered:

... health care clinics, including surgical centers and community health centers, are directed to provide such necessary health care services as instructed by CURE Action Team. Section 7 of this Order shall apply to any health care clinic, its employees and agents, who act in accordance with CURE Action Team instructions during this state of emergency. Such participating clinics shall be reimbursed or billed at a rate set forth in memoranda of understanding or such other standardized, uniform rate as developed by the CURE Action Team.

In light of the above, FHP Health Care Center was designated as a Tier Two urgent care facility. FHP has been directed to provide necessary health care services as instructed by CURE.

In your letter, you said:

We have not received any indication that any medical facilities, supplies, or providers have been formally directed to act as government entities.

We are confused as to whether FHP is part of the Tier Two urgent care facilities. Your letter seems to indicate that not only FHP, but also the Seventh day Adventist Clinic ("SDA"), and the American Medical Center ("AMC") clinics are not part of the Tier Two health care facilities despite EO 2020-06.

When the CURE Action Team initially met, the CURE team agreed that all the three (3) clinics and the hospitals would have different roles such as new operating hours and that GMH would only receive Covid-19 patients. FHP, SDA, and AMC, have not been acting on their own, and in fact, Dr. Michael Cruz, the surgeon general, knows full well that the three (3) clinics have been acting under the directions of EO 2020-06. Therefore, please clarify whether the three (3) clinics are operating under EO 2020-06 as government entities.

Finally, FHP appreciates your effort to expedite the payment of Medicaid/MIP to FHP.
