Dear Jayne:

It is most unfortunate you have not responded to any good faith efforts on my part to reach out to you. The plans we have already initiated for a new large umbrella foundation for the benefit of woman and children is exciting. We have hand picked our board of directors, all respected and credible members of our community. It was my hope you would at least have demonstrated an interest to meet with me since I had hoped for some form of public-private partnership.

I am confident the people of Guam will welcome this new foundation. I rarely say this Jayne but I did lead an entire effort to get a private hospital on Guam that resulted in over \$400,000,000 invested in our economy, the creation of over 700 private sector jobs as well as now the availability of healthcare for our people never available before. Myself and those that support the vision for this new women and children's foundation are confident that we will succeed the same way GRMC was developed without any government support. Sad to say, but the government at the time behind the scenes tried to stop us but we succeeded with the support of the people. And because this new foundation will operate in a manner with real transparency to our people, we know the people of Guam will support its purposes. I personally am excited about the realistic goals and objectives this foundation will have for our people especially for the health, safety and welfare of woman and children on Guam including unborn children.

I was sad to read the governor and your statement in response to the overturning of Roe. As far as literally over 100,000 people in our community truly feel, we may not have the monetary resources you have, but we have the guidance of our Lord to guide us. The overturning of Roe did not happen with a stroke of a pen. It was literally a 50 year very difficult advocacy for preserving the life of the unborn.

The recent reports in the media that now the governor is going to lobby senators to keep abortion legal and just ignore the Dobbs decision is not only sad, but disappointing. I personally cannot get out of my mind that Lou, in the capacity as a governor, publicly in the presence of children and the media referred to the heartbeat act as "full of shit". And I cannot forget her testimony opposing a Bill that mandated the saving of a baby's life if born alive after a botched abortion. And your mantra that the Supreme Court created a slippery slope of attacking other totally unrelated rights. Not once have I heard or read from you or the governor the term "child" or "baby" instead choosing to at least address the sanctity of the life of a child.

Jayne, I have attempted in good faith to reach out to you with no response. I thus can only assume that you could care less about the life of the unborn as well as well settled and decades of Canon Law you as a Catholic are governed by. The church has been reasonable and has followed the tenements of canon law. But under these laws of the Catholic Church, you have already been excommunicated under clear applicable canon laws without even the necessity of any action by the Archbishop. Your support, allegiance and dedication to murder innocent children violates the most basic principles of our church.

So I close by saying I tried to reach out to you. It was my hope that the Jayne Flores as an individual person separate from government will come back to the church. To expect the church will ignore your years of violating "Thou Shall Not Kill" is a risk on a soul I personally would not want on anyone. Under Canon Laws your advocacy for abortion not only places our Archbishop to ignore demonstrable evil, but also every single Catholic priest on Guam.

May God always bless you Jayne. I assure you that all this government authority comes in short bursts of life. But the true result of evil is eternal. Come back to your church Jayne. I believe our church will welcome you with open arms.
