Congratulations are also for the upcoming 54th-anniversary celebration when Brother Erano G. Manalo, Executive Minister of the Church of Christ (*Iglesia ni Cristo*), officiated the first worship service of God's people in the Far East in Ewa Beach, Hawaii. Then following Hawaii, *Iglesia ni Cristo* was first established here in Guam in 1960 when Guam was still undergoing rehabilitation and at its early stage of development

We both know the many positive impacts *Iglesia ni Cristo* has achieved in the Philippines, Guam, and worldwide. *Iglesia ni Cristo* was officially registered with the Government of Guam on March 17, 1969. The services were first held in a rented Quonset in Tamuning, Guam. This is now the spiritual house for several thousand worshippers and has come a long way from when *Iglesia ni Cristo's* initial group consisted of 50 members.
