## INVESTING IN OUR PEOPLE

- ✓ Increased take-home pay for teachers, nurses, law enforcement officers, attorneys, and public employees
- ✓ Invested a historic \$70 million to expand, improve, and stabilize childcare islandwide
- ✓ Expanded childcare access for working families and small businesses
- ✓ Launched Prugraman Pinilan to pay qualified relatives for family-based childcare
- ✓ Opened new workforce pathways through apprenticeships and trades training

## WORKFORCE AND EDUCATION PROGRESS

- ✓ More than doubled participation in the Guam Registered Apprenticeship Program
- ✓ Launched year-round paid internships for high school juniors and seniors
- ✓ Connected students directly to private-sector employment opportunities
- ✓ Advanced construction of UOG's School of Engineering, Nursing Annex, and WERI facilities

- ✓ Initiated operational and financial assessments of Guam Memorial Hospital

## ECONOMIC DIVERSIFICATION AND INNOVATION

- ✓ Supported over 70 small businesses through GUMA incubator programs
- ✓ Secured a multi-million-dollar Department of Defense additive manufacturing partnership
- ✓ Positioned Guam as a hub for advanced manufacturing and data management
- ✓ Partnered with Google to lay subsea cables connecting Guam to global data networks
- ✓ Strengthened Guam's role in regional supply chains and technology infrastructure

## RELIABLE POWER AND GOVERNMENT MODERNIZATION

- ✓ Issued emergency procurements to prevent summer power shortages
- ✓ Took action to protect the grid from load shedding
- ✓ Delivered a new Financial Management Information System after 30 years of delays



